

ORDINANCE NO. 01-07

AN ORDINANCE AMENDING TITLE 3, CHAPTER 3, SECTION 29(19)
OF THE 2005 CODE OF ORDINANCES OF THE CITY OF EXIRA, IOWA

BE IT ENACTED by the City Council of the City of Exira, Iowa:


SECTION 1. 3-3-29 STOPPING, STANDING OR PARKING PROHIBITED In
SPECIFIED PLACES. NO person shall stop, stand or park a vehicle except when necessary to
avoid conflict with other traffic or in compliance with the directions of a police officer or traffic-
control device in any of the following places:

19. On the west side of Fairview Street from its north end south to Depot Street.


SECTION 2. All other provisions of Title 3, Chapter 3. Section 29 remains in full force
and effect.

ORDINANCE NO. 09- 02

AN ORDINANCE AMENDING TITLE IV, CHAPTER 1, SECTION 2
OF THE CODE OF ORDINANCES OF THE CITY OF EXIRA, IOWA

BE IT ENACTED by the City Council of the City of Exira, Iowa:

1. That Section 4-1-2 of the Code of Ordinances of the City of Exira, Iowa is hereby amended by adding to the second paragraph of the Section the sentence:

"No household shall have more than four cats"

so that the whole section now reads as follows:

4-1-2 LICENSE. Every owners of a dog or cat over the age of six (6) months shall procure a license from the City Clerk-Treasurer on or before the first day of January of each year. Such license fee shall be due and payable between January 1 and March 31 of each year.

The annual license fee shall be \$10.00 per dog and \$5.00 per spayed or neutered dog. No household shall have more than two dogs. The annual license fee for cats shall be \$10.00 per cat or \$5.00 per spayed or neutered cat. No household shall have more than four cats.


Upon payment of the license fee, the City Clerk-Treasurer shall issue to the owner a license which shall contain the name of the owner, the owner's place of residence and a description of the cat or dog. The City Clerk-Treasurer shall keep a duplicate of each license issued as a public record.

Upon issuance of the license, the City Clerk-Treasurer shall deliver to the owner a metal tag stamped with the number of the license and the year for which it is issued. The license tag shall be securely fastened to a collar or harness which shall be worn by the cat or dog for which the license is issued.

Any cat or dog found running at large without the license tag attached to its collar or harness shall be deemed unlicensed.

An owner of an unlicensed cat or dog shall be subject to a fine of \$25.00.

The Mayor and City Clerk are hereby directed to enter and sign an endorsement to this amendment to the Code of the City of Exira, Iowa passed by the City Council of the City of Exira, Iowa this 14th day of September, 2009.

ORDINANCE NO. 08- 02

AN ORDINANCE AMENDING TITLE VI, CHAPTER 4, SECTION 15
OF THE CODE OF Ordinances OF THE CITY OF EXIRA, IOWA

BE IT ENACTED by the City Council of the City of Exira, Iowa:

1. That Section 6-4-15 of the Code of Ordinances of the City of Exira, Iowa, which presently reads as follows:

6-4-15. WATER RATES. Water shall be furnished at the following monthly rates per user within the City limits:

All users, commercial and non-commercial:

A minimum fee of \$16.00 per month if their water connection is within the Exira City limits and an additional \$3.50 per thousand gallons or part thereof for all water used in excess of 2,500 gallons per month.

A minimum fee of \$26.00 per month if their water connection is outside the Exira City limits and an additional \$4.00 per thousand gallons or part thereof for all water used in excess of 2,500 gallons per month.

Is hereby amended to read as follows:

6-4-15. W ATER RATES. Water shall be furnished at the following monthly rates per user within the City limits:


All users, commercial and non-commercial:

A minimum fee of \$18.00 per month if their water connection is within the Exira City limits and an additional \$ 4.25 per thousand gallons or part thereof for all water used in excess of 2,000 gallons per month.

A minimum fee of \$28.00 per month if their water connection is outside the Exira City limits and an additional \$4.75 per thousand gallons or part thereof for all water used in excess of 2,000 gallons per month.


2. This ordinance as amended shall take effect on January 1, 2009.

OF THE CODE OF ORDINANCES OF THE CITY OF EXIRA, IOWA


BE IT ENACTED by the City Council of the City of Exira, Iowa:

- 1, That Section 6-3-4 of the Code of Ordinances of the City of Exira, Iowa is hereby amended by striking there from the words "35%" so that the paragraph reads as follows:

6-3-4, RATE OF RENT AND MANNER OF PAYMENT. The rate of sewer
rent the 50% of the monthly water bill per user, effective January 1st, 2009.
